All booth spaces are \$50.00 regardless of their location. Booth spaces are 10' x 10'. Vendors must bring their own canopy, chairs, tables, etc. Strict limit of two crock pot sized appliances. Electricity is included.

Note to Food Vendors: First come, first served for exclusive food offerings. Setup time is 5:00 p.m.

Space rates will increase by \$5.00 10 days before the event (if space is still available).

Booth space fills up quickly, so be sure to reserve yours early!

In order to participate in the Port Isabel's City of Port Isabel Community Christmas Tree Lighting Ceremony, ALL VENDORS must agree to the following provisions below:

2. In consideration of the use of one or more spaces by the undersigned vendor participation in Port

Isabel's City of Port Isabel Community Christmas Tree Lighting Ceremony, the undersigned agrees to defend, indemnify, and hold harmless the City of Port Isabel, its officers, agents, employees, and members from and against all liabilities, claims, suits, or demands for injuries to any person and/or property arising out of the undersigned's injuries to persons he or she may cause by participating in such activities.

DO NOT RUN FANS, HEATERS OR OTHER PERSONAL CONVE- NIENCES.
